

ORDINANCE NO. 2021-O-04

AN ORDINANCE AUTHORIZING THE PURCHASE OF A FORD F-150 PICKUP THROUGH THE SUBURBAN PURCHASING COOPERATIVE BY THE WEST CHICAGO FIRE PROTECTION DISTRICT

WHEREAS, the West Chicago Fire Protection District (the "District") is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Illinois Fire Protection District Act (the "Act") grants authority to the Board of Trustees (the "Board") to purchase property for the purpose of fire protection; 70 ILCS 705/6; and

WHEREAS, the Board has determined that a need exists for the acquisition of apparatus for purpose of fire protection within the District; and

WHEREAS, the Suburban Purchasing Cooperative has issued bids for the purchase of a Ford F150 Pickup from several manufacturers; and

WHEREAS, the Board has determined that it is in the best interest of the District to purchase a Ford F150 Pickup through the Suburban Purchasing Cooperative.

NOW THEREFORE, Be it ordained, by the Board of Trustees of the West Chicago Fire Protection District, DuPage County, Illinois, as follows:

Section One: The President and Secretary of the Board are authorized to enter into a purchase agreement with Roesch Commercial Truck Center, Bensenville, IL. for the purchase of a Ford F150 Pickup in substantially the same form as the agreement attached hereto as Exhibit A.

Section Two: This Ordinance shall be in full force and effect upon to adoption and shall supercede and agreement, ordinance, or motion in conflict with any part herein, any such agreement, ordinance, or motion or part thereof is hereby repealed.
