

ORDINANCE NO. 2022-O-06

ORDINANCE AMENDING THE RANK STRUCTURE AND DEPARTMENT ORGANIZATION OF THE WEST CHICAGO FIRE PROTECTION DISTRICT

WHEREAS, the Board of Trustees of the West Chicago Fire Protection District (hereinafter "the District"), DuPage and Kane Counties, Illinois, has previously adopted an ordinance establishing the rank structure for the District; and

WHEREAS, the Board has determined that there is a need to amend the existing rank structure and department organization regarding the name/title of the rank of Assistant Chief for the District.

NOW THEREFORE BE IT ORDAINED by the Board of Trustees of the West Chicago Fire Protection District, DuPage and Kane Counties, Illinois as follows:

Section 1: Composition of Department

Effective with the passage of this ordinance, the title/rank of Assistant Chief shall be called Deputy Chief.

Section 2: Rules and Regulations

The Chief of the Fire Department shall enforce the Rules and Regulations for the Government of the Officers, Members and employees of the District previously adopted by the Board of Trustees. The Chief shall also prescribe such additions to or amendments of said Rules and Regulations as he deems advisable, which additions and/or amendments shall then be presented to the Board of Trustees for adoption. Said Rules and Regulations may cover, but not be limited to; the conduct of members, uniforms, equipment to be worn or carried, hours of service, physical fitness and appearance, hair styles, vacation and all other similar matters necessary and desirable for the better efficiency of the Department.

Failure to comply with the Rules and Regulations of the District, or orders of a superior officer shall result in disciplinary action.

Section 3: Effective Date of Ordinance

This Ordinance shall be in full force and effect upon its adoption.

Section 4: The Ordinance shall supersede any ordinance, resolution, motions or parts of such which in any way conflict with any part herein. And any such ordinances, resolutions or motions or parts thereof are hereby repealed to the extent of any conflict.




